2025 OFFICIAL RULES AND REGULATIONS

ALL RULES HAVE "LOOPHOLES" IN THE INTEREST OF GOOD SPORTSMANSHIP, ENTRANTS ARE REMINDED THAT THE "SPIRIT OF THE RULE" WILL PREVAIL IN ALL JUDGEMENTS.

ELIGIBILITY – A complete and signed form and a paid entry fee of \$50.00 per boat/team must be paid before the tournament day, contestants must enter as two person teams

SAFETY – All contestants must observe U.S. Coast Guard regulations. No shotgun starts. "no wake" zones must be obeyed.

SPORTSMANSHIP – Contestants are expected to be courteous, safety conscious and practice fundamental sporting principles.

TACKLE AND EQUIPMENT – Artificial or live bait may be used, each person may use 2 fishing rods. You may carry spares in your boat.

BOAT AND MOTORS – Must meet U.S. Coast Guard regulations for the use by 2 persons. Motor size depends on the size of the boat.

HEADQUARTERS – Fort Randall Casino (Must attend morning meeting at Duck Inn to participate)

FISHING AREA – Fort Randall tail waters to Nebraska border and Lake Francis Case lake west to pease creek and south scalp bays.

FISHING HOURS – Start at 7:00 am and must check in no later than 3:30 pm at the Fort Randall Casino. Contestants who return later than the scheduled time will be disqualified.

SCORING – Prizes will be based on the most weight, each team will be allowed to weigh 7 fish. Walleye, saugeye or sauger will be weighed in only if they measure 15 inches long or over. Fish measuring less than 15 inches will result in a disqualification for all fish that day. Each person may have one fish 20 inches or longer. Any fish mangled, mashed or mauled will be disqualified. High grading of fish prohibited.

TIES – Ties for prize money will be resolved by combining the place winnings for the tied positions and splitting the winnings between the teams that are tied.

PRIZES – Prize money will be paid to winning teams. Number of places will be determined by number of entries.

INSPECTIONS – Boats may be inspected before and during the tournament.

CONTESTANTS NOTES – It is illegal for two boats or more to pull up to each other during tournament hours. Coming ashore won't be allowed except in emergencies.

LICENSES – A South Dakota current fishing and boat license is required.

GENERAL – All rulings by the tournament officials are final. The tournament committee has the right to refuse any entry.

NOTE – The Lake Andes fish day committee or any other tournament sponsor will not be liable for any accidents, loss or damage of property, or personal or bodily injury in connection with this tournament.
